THE WINTER FESTIVAL CONSISTED OF THIRTY-THREE PERFORMANCES, TWO MORE THAN THE PREVIOUS YEAR. FOUR DIFFERENT OPERAS WERE PRESENTED IN FRONT OF OVER 28,000 PATRONS.
